It happens every summer.

A dog (and/or child) is left alone in a hot car to suffer a horrific death.

Just a few minutes can be deadly. Please see Temperature Chart link, courtesy of the American Veterinary Medical Association:

This is an avoidable tragedy! 25 States have already enacted some form of "Hot Car" legislation, and several more states have bills pending.

South Carolina urgently needs to implement our own "Hot Car" legislation:

- 1) impose specific cruelty/neglect/abuse penalties
- 2) pass laws that grant civil & criminal immunity to "Good Samaritans" to allow reasonable forcible entry to save lives
- 3) empower Animal Control, Law Enforcement, Firemen, and other First Responders to forcibly gain entry to save lives

Both Tennessee and Florida have implemented the "Good Samaritan" option. In this type of dangerous situation,

every minute counts and Law Enforcement assistance varies with response times due to availability and priority.

I would like to see South Carolina adopt similar legislation!
